Rewards Checking Qualification & Cycle Dates

Qualifying Cycle: The period beginning two days prior to the last Statement Cycle through three days prior to the current Statement Cycle. Eligibility requirements must be completed (posted and cleared) during each Qualifying Cycle.

To qualify for the preferred rewards rate, you must fulfill the following requirements during each Qualifying Cycle: ensure successful enrollment for receiving monthly statements electronically, make at least 15 posted and cleared debit card purchases (note that transactions made at ATMs are excluded), and receive at least one ACH direct deposit totaling \$1,000 or greater; the required total for clients aged 65 and above is \$500 or greater.

If qualifications are met, the preferred rate and ATM rebates up to \$10 will be applied
